**NORMS AND PROCEDURES FOR THE IMPLEMENTATION OF ACADEMIC  
FREEDOM, ACADEMIC PULPIT FREEDOM, AND SCIENTIFIC AUTONOMY  
IPB UNIVERSITY**

Consider:

- a. that Government Regulation Number 66 of 2013 concerning the Statute of the IPB University, states that the Academic Senate of IPB has the authority to make norms and supervise the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy;
- b. that Academic Freedom, Freedom of Academic Pulpit and Scientific Autonomy are prerequisites for the creation of a climate that supports the development of science, technology from the series by the IPB University's academic community;
- c. that in connection with points a and b, it is necessary to stipulate Norms of Academic Freedom, Freedom of the Academic Pulpit and Autonomy of Intellect with a Regulation of the Academic Senate of the IPB University;

GENERAL UNDERSTANDING

Section 1

Definition

- a. IPB University, hereinafter abbreviated as IPB, is a legal entity state university.
- b. The leader of IPB is the Chancellor of IPB.
- c. The Chancellor is the organ of IPB who leads the implementation and management of IPB.
- d. The Academic Civitas is an academic community consisting of lecturers and students.
- e. Lecturers are professional educators and scientists with the main task of transforming, developing, and disseminating Science, Technology and the Arts (IPTEKS) through Education, Research, and Community Service.
- f. rofessor, hereinafter referred to as Professor, is the highest functional position for lecturers who are still teaching in



- the higher education unit.
- g. Students are students at the higher education level at IPB.
  - h. Academic freedom is the freedom of the Academic Civitas in Higher Education to explore, develop, and disseminate science and technology responsibly through the implementation of the Tridharma in accordance with the scientific authority.
  - i. Freedom of the academic pulpit is the authority of Lecturers who have doctoral or equivalent qualifications who have scientific authority and authority according to their knowledge in disseminating research results and conveying academic views through scientific oration activities, lectures, seminars, and other scientific meetings, as well as scientific publications in accordance with the rules. their knowledge responsibly.
  - j. Scientific autonomy is the flexibility and authority of the academic community in carrying out scientific activities to master and develop science and technology based on academic norms and culture as well as responsible scientific principles.
  - k. Scientific authority is the authority of a lecturer who masters certain science and technology and is recognized by scientific colleagues and/or appropriate institutions to provide an assessment of exposure to science and technology in his field of expertise.
  - l. The academic forum is a forum for conveying thoughts and opinions on academic issues in the context of implementing the responsibilities of the academic pulpit.
  - m. Academic ethics are the values and rules of conduct of the academic community above the legal provisions that set moral boundaries for the actions of the academic community in academic activities that include scientific ethics and campus life ethics.
  - n. Scientific ethics are values or rules of behavior that support the effective development of science and technology, and the integrity of the academic community in carrying out scientific activities.
  - o. College life ethics are values and rules related to the integrity of the academic community in their relationships with each other in campus life as an intellectual community.
  - p. Scientific norms and rules are principles that must be adhered to in carrying out scientific activities, namely systematic, coherent, principle-abiding, measurable, tested and objective.
  - q. Rules are rules that must be obeyed or implemented.



## PRINCIPLES, OBJECTIVES AND SCOPE

### Section 2

#### **Principle**

Academic freedom, freedom of academic pulpit and scientific autonomy in the implementation of education and development of science and technology are based on:

- a. Academic ethics;
- b. Scientific norms and rules;
- c. scientific truth;
- d. reasoning;
- e. honesty;
- f. justice;
- g. benefit;
- h. virtue;
- i. responsibility; and
- j. diversity;

### Section 3

Academic freedom, freedom of academic pulpit and scientific autonomy aim to guarantee the academic community to be able to develop science and technology responsibly.

### Section 4

#### Scope

- (1) Academic freedom is carried out in an effort to provide responsible education, development and dissemination of science and technology through Tridharma activities.
- (2) The scope of academic freedom, freedom of academic pulpit and scientific autonomy includes all educational, research, and community service activities organized by IPB and or individual academics.
- (3) Academic freedom, freedom of academic pulpit and scientific autonomy are carried out in the Academic Forum in the form of.-
  - a. scientific oration;
  - b. scientific judgment in a legal case;
  - c. scientific and/or popular publications;
  - d. scientific and/or popular seminars;
  - e. general study,



- f. guest lecture;
  - g. lectures and/or practicum;
  - h. training;
  - i. interviews and/or broadcasts in the media;
  - j. other scientific meetings.kuliah tamu;
- (4) Forum Akademik dilaksanakan di IPB atau tempat lain atas penugasan Pimpinan IPB atau pejabat yang diberi kewenangan oleh Pimpinan IPB.

## **APPLICATION AND PROCEDURE**

### Section 5 Academic Freedom

Academic freedom is carried out by providing flexibility for lecturers to determine scientific development priorities and for students to choose the field of study they want in accordance with applicable regulations.

### Section 6 Freedom of the Academic Pulpit

The freedom of the academic pulpit is realized by giving freedom to the academic community to express their thoughts and opinions responsibly according to their authority.

### Section 7 Scientific Autonomy

- (1) Scientific autonomy is developed through an expert system that is open to the academic community in various fields of science and technology.
- (2) Scientific authority is realized by acknowledging the authority of lecturers who master certain science and technology to provide an open and transparent assessment of exposure to science and technology in their field of expertise.

### Section 8 Implementation of Supervision

- (1) The Academic Senate supervises the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy whose authority is delegated to the Ethics Committee of IPB;



- (2) The arrangement for the implementation of supervision as referred to in paragraph 1 is regulated in the Rector's Regulation with the approval of the SA.

## **OBLIGATIONS, RESPONSIBILITIES, RIGHTS AND AUTHORITIES**

### Section 9

#### Duties and Rights of the Academic Civitas

- (1) In exercising academic freedom and or freedom from the academic pulpit, as well as scientific autonomy, the academic community is obliged to:
- seek activities whose results can improve academic quality;
  - strive for activities and results that are beneficial to the community, nation, state, and humanity;
  - carry out activities that do not conflict with religious values, norms, and academic ethics, as well as scientific principles in accordance with the rules determined by IPB;
  - carry out activities that do not violate laws and regulations; and
  - report the activity plan to the IPB Leader or an official authorized by the IPB Leader to obtain a permit and/or assignment.
- (2) In exercising academic freedom and or freedom from the academic pulpit, as well as scientific autonomy, the academic community has the right to:
- get legal protection from IPB for the implementation of academic freedom in academic forums.
  - Granting or not giving permission for recording, editing, and distributing documents or the like by other parties.
  - reviewing, approving and/or canceling the results of point 2b for dissemination if it is deemed no longer appropriate with the substance of the academic forum.
  - obtain legal assistance from IPB in the event of a violation by another party of points 2b and 2c.

### Section 10

#### Obligations and Rights of IPB

- (1) In the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy, IPB is obliged to:
- ensure that the academic community can exercise academic freedom, freedom of academic pulpit, and scientific autonomy





- according to ethics and academic norms as well as statutory provisions/regulations.
- b. enforce the rules for the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy by the academic community in accordance with the provisions/regulations of legislation.
  - c. facilitating infrastructure and facilities, fostering and guaranteeing an atmosphere so that the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy, is optimally in the context of carrying out its duties and functions.
  - d. provide legal protection and assistance for the implementation of academic freedom in academic forums.
- (2) In the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy, IPB Leaders have the right to:
- a. obtain a written report on the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy.
  - b. monitor and evaluate the implementation of academic freedom, freedom of academic pulpit, and scientific autonomy.

#### Section 11 Duties and Rights of Lecturers

- (1) In carrying out academic freedom, freedom of academic pulpit and scientific autonomy, every lecturer is obliged to comply with this regulation and the provisions of the legislation.
- (2j) In accordance with their academic authority, lecturers have the right to exercise academic freedom, freedom of academic pulpit and scientific autonomy in accordance with statutory provisions/regulations.

#### Section 12 Student Obligations and Rights

- (1) In carrying out academic freedom and scientific autonomy, every student is obliged to comply with this Regulation and the provisions of the legislation.
- (2) In accordance with their academic status, students have the right to exercise academic freedom and scientific autonomy in accordance with statutory provisions/regulations.

#### Section 13 Penalty

- (1) Violation of the rules for the implementation of academic freedom,



freedom of academic pulpit, and scientific autonomy are subject to sanctions in accordance with statutory provisions/regulations.

- (2) The rules and sanctions as referred to in paragraph (1) shall be further regulated in the Rector's Regulation.

Closing Prevision

- (1) Decree of SA IPB Number 21/I/KSP/SA/2003 concerning Guidelines for the Implementation of Academic Freedom, Freedom of the Academic Pulpit and Scientific Autonomy of the IPB University is revoked and declared null and void.
- (2) The norms of academic freedom, freedom of academic pulpit and scientific autonomy are effective from the date of stipulation.
